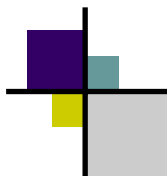

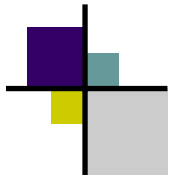

Highlights of July 22, 2009, Member Meeting

Sunshine Committee: A motion was made by Carl Cain and passed to correct the past minutes to show that Paul and Tyra Russell were confirmed as co-chairs of the Sunshine Committee.
