## JOIN OUR TELL AMERICA TEAM, Chair: Gloria Corbet 483-0570

Our Chapter's Tell America Program is over for the 2015-2016 School Year. It ended when Brian and Teresa Welke and Joel Briggs attended the Leesburg High School (LHS) Awards Banquet at Venetian Gardens on Friday, May 20. We gave the LHS JROTC a check for \$500 for cadet programs.

We had done similarly at Eustis and Mount Dora High Schools, and St. Paul Middle School.

We have tried to add more schools but so far have not been successful.

Our Tell America Team is down to 12 active members. Several have not been able to participate for a few years.

If you are interested in participating, we do a minimum of 4 schools a year.

St Paul's in Leesburg is a 1 to 1 1/2 hour presentation to 5th through 8th graders. They are required to participate in a school project based on our presentation so we usually have rapt attention from the whole group. We go back late in the school year and present small checks to the winners of the school selected project. This past year it was essays and posters. We also give a check to the School.

At the Mount Dora, Leesburg, and Eustis High Schools, we spend a day with the cadets, and any other class (history, etc.)

that the ROTC leader invites to our presentations.

We usually do at least 6 sessions in the day, and get a lunch. We attend their ROTC Banquets in April or May. That's when we present the checks for the Jr. ROTC programs.

With Joel not able to continue the program, we need a Korea Defense Service Veteran to be the wrap up speaker of each presentation. This would involve telling what you did in Korea and how Korea has recovered from the war. We have lots of material from which to choose what to say to wrap up.

Don has contributed impressively to 44 volunteer and service organizations, including the Korean War and Korea Defense Service Veterans Association of Lake County, Chapter 169, Florida.

## Korean War Remains Recovery in Jeopardy

Construction of a hydroelectric plant in North Korea could thwart efforts to recover up to 1,600 sets of remains of missing U.S. Korean War soldiers.

A valley in Kujang County that was the site of major Korean War battles in late 1950 will eventually be flooded after the communist country builds a dam to power the Chongchon River No. 10 Hydroelectric Station.

North Korea began construction of the plant about four years ago. In the process, digging in the area of the village of Ryongyon-ri, some 100

miles north of Pyongyang, uncovered a substantial number of bones. According to an Associated Press report, they could represent from 70 to 100 sets of remains.

At this point, there is no evidence that the remains are those of U.S. troops, or even humans. Skeptics say that North Korea is using construction of the dam as leverage for restarting talks to resume U.S. remains recovery operations and collecting payment for them.

Joint U.S.-North Korea recovery teams collected 229 sets of American remains during 33 operations

from 1996-2005. The U.S. stopped the searches when the safety of its members could not be guaranteed. Then, six years later, the U.S. broke off talks to restart the program when North Korea conducted a ballistic missile test. There is no schedule "at this time" to resume talks.

DPAA says Kujang County could yield up to 1,600 sets of remains. Almost a dozen searches were conducted there between 1998-2000.

DPAA noted that as of March 21, 2016, a total of 7,820 Korean War GIs remain are unaccounted for.

### LAKE COUNTY MAN among the 7,820 MIAs in NORTH KOREA!

**Cpl Charles Wesley Thomas**, Born: December 4, 1932, Home Or Place Of Enlistment, Lake County, Florida. Service Number: Ra14331999, Bronze Star, 65th Infantry Regiment, K Co 3rd Bn, 3rd Infantry Division, US Army, Hostile, Died While Missing (MIA), Remains Not Recovered, Date of Loss: July 6, 1953, he was presumed dead on July 7, 1954.

Extracted from the "3rd Division Command Report for 65th Infantry Regiment July 1953"

"On July 1953 the 65th Infantry Regiment occupied a sector of Line Missouri from CT516408 to CT594429 (believed to be in general area of Outpost Harry).

On the 6th of July 1953, Company "K" conducted a raid on enemy held Hill 250, CT592446. At 0020 hours the support platoon departed the MLR, followed 15 minutes later by the assault platoon. After passing through the support position the assault element reached the attack position at 0222 hours and was ordered to move out. With 2 squads abreast, the assault element moved over the first objective at 0233 hours and along the northern ridge without incident. Upon approaching the second objective at 0237 hours, they were met by fire from an unknown number of enemy. At this time the assault element began receiv-

ing artillery, mortar, small arms, and automatic weapons fire from the high ground, known as "Green Knob," to the northeast of Hill 250. When this fire-fight intensified at 0251 hours, the support element was committed.

The support platoon approached the objective and swept the southwest ridge. At 0302 hours, as they became heavily engaged, the alert platoon was also committed, having already moved to the old support platoon position. They swept the objective at 0320 hours for all remaining friendly and enemy casualties and at 0335 hours all elements began a withdrawal to the MLB over the prearranged return route. The enemy continued to blanket the objective with fire and, as the friendly elements withdrew, continued to roll this fire after them. Upon reaching the MLR with this fire, the enemy continued to fire on the MLR positions for some time.

The first elements of the raiding party reached the MLR at 0434 hours, the friendly casualty report being, 3 KIA 10 MIA and 20 WIA.

At 10:55 hours a Searching patrol was dispatched to the area of contact to try to locate missing persons. They could observe two (2) bodies but could not make any positive identification. [end quote]

Cpl. Thomas likely was one of the 10 MIA's reported.
